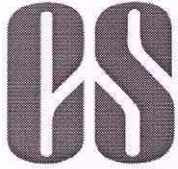

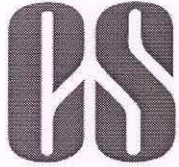

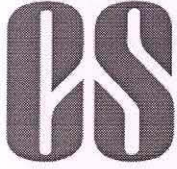

**Note:**

1. The Company had received an order dated August 11, 2021 from the Securities and Exchange Board of India under Sections 11(1), 11(4) and 11B of the SEBI Act, 1992, in connection with alleged violations of the provisions of the SEBI Act, 1992, the Securities and Exchange Board of India (Prohibition of Fraudulent and Unfair Trade Practices relating to Securities Market) Regulations, 2003, and the Securities and Exchange Board of India (Delisting of Equity Shares) Regulations, 2009, in the matter of Riddhi Siddhi Gluco Biols Limited. Pursuant to the said order, the Company was restrained from accessing the securities market and dealing in securities for a period of two (2) years. The Company preferred an appeal before the Securities Appellate Tribunal, and the Hon'ble Tribunal, vide its interim order dated October 28, 2021, had granted a stay on the operation of the aforesaid SEBI order. Subsequently, the Hon'ble Securities Appellate Tribunal, vide its final order dated March 09, 2026 in Appeal No. 617 of 2021, has set aside the aforesaid debarment of two (2) years and modified the same to a period of three (3) months from the date of the said order.

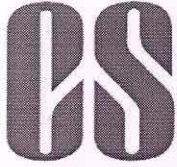
